Sub:- **To issue of the No Objection Certificate to Akal Academy, Bakarwal, District Moga in order to get affiliation from C.B.S.E. New Delhi.**

Sir,  
In the reference of the above mentioned subject.

2. After seeing thoroughly the documents including Affidavit presented by School Management, recommendations of District Education Officer (S. E.) Moga and Director Education Department (S.E.), Punjab, Chandigarh, the No Objection Certificate is issued by the Punjab Government as per the following terms:-

1. If any fact comes in future on the basis of any complaint/ inspection that you have submitted wrong information in the application at the time of getting No Objection Certificate and or you do not follow the instructions of Punjab Government from time to time and do not keep following the terms mentioned in the affidavit, then in that condition the No Objection Certificate may be taken back at any time.

2. It will be compulsory to teach Punjabi upto matriculation level in your school and C.B.S.E./I.C.S.E. New Delhi will make efforts surely to conduct examination of Punjabi in such schools and it is also mentioned that in the condition of not doing that, the No Objection Certificate may be taken back at any time.

3. That School Management will follow completely the Notification issued under R.T.E.Act 2009 by the Punjab Government and the rules of R.T.E. Act-2009 issued for Punjab state.

4. After getting the affiliation of C.B.S.E. New Delhi, the School Management will be held responsible to pay the salaries and other allowances etc. through the payee cheques to the teaching staff and non-teaching staff like government employees.

5. You, yourself and your management will also make it compulsory that whenever the information is demanded by the Education Officer of your district or any Senior Officer, then you will provide the necessary information to him and

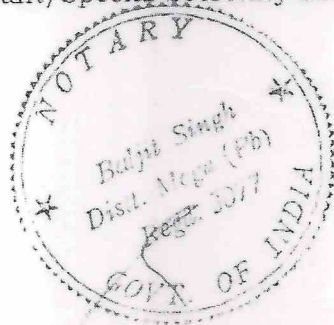
